## ADJUTANT/QUARTERMASTER

The IRS has hired new agents to look into 501(c)(19) organizations reporting practices. The IRS is looking for **Unrelated Business Income (UBI)** which is requires the filing of Form 990T. They are also looking for Form 730 and Form 11-C, which pertains to gaming tax.

If your Post has a mortgage on the building and you rent the hall, you may be subject to UBI tax because of the mortgage. They are also looking into how many non-members are being served at the Post canteens. If your Post puts up a sign and indicates that you are having a lunch or dinner on your marquee, and you do not indicate that it is for members only, you may be subject to UBI tax.

All Posts need to make sure that they have signs up in their entrance and on all

machines (i.e. pool tables, pull tabs and any other machine in the building) that the use of machines is for members only. You also need to keep copies of the community activities and hospital activities that the Post does. This shows that you are maintaining the purpose for which the Post is a nonprofit organization.

## Department Service Officer SUCCESS STORY

In the summer of 2000, one of our staff members was at a military reunion and had a conversation with another attendee who inquired what our staff member did for a living. After finding out that he was a Veterans' Advocate, he told a story of being diagnosed with a disability shortly after he was discharged from service. In fact, the veteran advised our Advocate that he had been put on medication and that he was sure that it was within a year of his discharged date.

**38 CFR §3.309 Disease subject to presumptive service connection**, states that a disease that is chronic in nature and manifests itself to a 10% degree of disability within the legal presumptive, normally 1 year, may be service-connected. Knowing

this information, the Advocate filed a claim in December of 2000 with the VA for the condition that the veteran was diagnosed with back in the early 60s.

In May of 2001, the VA denied the claim on the basis the veteran's service medical records were silent regarding any symptoms relative to the claimed condition. In the initial claim, medical statements from private physicians clearly showed that they remembered that the veteran had the condition shortly after service. The statements were very specific, but the VA stated that in light of the detailed statements provided by the doctors, they should be able to produce the actual chart that was being kept at the doctor's office.

The rating specialist, no longer employed by the VA, stated that the veteran's doctors have remarkable memories as to the date of the veteran's employment physical, but their memories are unsupported by documentation. Personal comments made by a VA employee regarding the integrity of a claim only makes an Advocate fight harder.

**38 CFR §4.23 Attitude of rating officers**, states it is to be remembered that the majority of applicants are disabled persons who are seeking benefits of law to which they believe themselves entitled. In the exercise of his or her functions, rating officers

## STATE SERVICE OFFICER

### Advocating for Others

For this article, we wish to help dispel some confusion regarding the reimbursement of private medical treatment that is not done by the Department of Veteran Affairs (DVA). Currently, there are only two programs available in which the VA will reimburse a veteran for treatment at a non-VA facility. These are the Millennium Healthcare Act (MHA) and reimbursement of non-authorized healthcare.

Under the MHA, there are several key factors. First, the veteran must be enrolled into the VA healthcare system at the time of the treatment. Finally, there must be no third party payee to the bill. This means that no agency, program, insurance or persons has assisted in paying any part of the bill. In such cases, VA must be payer of last resort. Examples of this would be private medical insurance, Medicare or Medicaid. As soon as any portion of the bill has been paid, the veteran is no longer eligible under the MHA. VA may reimburse or pay eligible claimants for non-VA emergency medical treatment rendered to an eligible veteran on and after May 29, 2000. Claims must be submitted within 90 days from the date of care.

A veteran may also seek reimbursement for non-authorized private treatment at non-VA facilities. First and foremost, we urge veterans to obtain

prior authorization. Unfortunately, circumstance may not allow this.

1. The veteran is currently enrolled into the VA healthcare system at the time of the treatment, and
2. The veteran has sought treatment for a service-connected condition, and
3. Seeking treatment at a VA facility is unfeasible either by distance to be traveled or the nature of the treatment required, and
4. The hospital care or treatment was serious threatening to life or health, until the veteran can be safely transferred to a VA facility, and
5. The veteran or someone on his or her behalf notified the DVA within 72 hours of admission. Make sure you get a name of the person you talked to, a date and time when the call was made.

It is important to note that the reimbursement is for treatment to stabilize the patient for transportation to a VA facility. It is the VA who determines if the condition was life threatening, and when the veteran has been stabilized for transportation to a VA facility.

Claims must be filed with the VA hospital serving the area within two years of the date the services were provided.

Whenever possible, obtaining pre-authorization for private treatment is highly recommended.

## VSO's Share Resources and Support

In response to the recent budget crisis negatively impacting service and outreach to veterans and their families in the State of Michigan, and in a tremendous display of camaraderie and teamwork, The American Legion (AL), Disabled American Veterans (DAV), Marine Corps League (MCL), Military Order of the Purple Heart (MOPH) and Veterans of Foreign Wars (VFW) developed a statewide teaming agreement with the goal of supporting each other, both at the VA Regional Office and in field operations.

As a result of this teaming agreement, any Service Officer from one of the organizations previously mentioned may attempt to assist you with your claim. While there still may be some legal restrictions on the level of detail in which they can immediately render service, these highly trained professionals will

ensure that someone from the organization you have assigned as your official power of attorney will follow up.

"Our Service Officers have a long and storied tradition of completing 'courtesy claims' for one another," said DAV Director Tom Wendel. "We have simply formalized what we have already been doing in practice for so many years in the State of Michigan."

Another benefit of the teaming agreement is that it allows already limited resources to be stretched a little further, thus affording even more veterans, dependents and survivors the opportunity to apply for benefits from the U.S. Department of Veterans Affairs. "This is an unprecedented effort amongst veterans service organizations in this state," reports VFW Director Dan Crocker. "While it was born out of necessity, I think it can benefit us all in the long run."

## Michigan Freedom Academy 2010


This year's Freedom Academy was one of the best ever. Accompanying me on this year's Civic Leaders Tour was Dept. Adjutant Quartermaster Rob Weiss and Ladies Auxiliary PSP & Freedom Foundation Board of Directors member Sandi Onstwedder.

The tour started at Capitol City Airport where we all boarded a MIARNG CH-47 Chinook. The Flight to Phelps-Collins ANG Base took about an hour. An interesting part of this year's flight was that all passengers, one by one, were allowed to get into a harness, attached to the floor of the aircraft and ride on the lowered tail ramp. It's quite an experience sitting with your legs dangling in space, at 150 mph, 1,000 ft. above the ground.

We were next treated to coffee and cookies before attending a welcome brief at Base Operations. It was there I was introduced to Lt. Col. Alexander Jefferson (Ret.). Mr. Jefferson was a Tuskegee Airman who flew P-51s out of Italy during WWII. He was shot down during the invasion of southern France, interned in a POW camp, and later released. He has published a book about his experiences, entitled, "Red Tail Captured, Red Tail Free." In conversation with him I discovered that he knew my uncle, Capt. Thomas Patton, who was also a Tuskegee Airman.

From Base Ops we went on a bus 'windshield tour' of the Combat Readiness Training Center (CRTC). This is an excellent facility which provides a year-round realistic training environment for military units from all over the United States. The Freedom Academy delegates and staff are housed in some of the 43 dormitories available onsite. They are capable of accommodating over 1,000 people.

Next we went to the Collins Center, where Lt. Col. Jefferson and Maj. Gen. William Henderson (Ret.) were giving a presentation on the Tuskegee Airmen. A fifteen-minute film on the Tuskegee pilots training and exploits during WWII was shown, and both gentlemen answered questions from the delegates. The delegates seemed to enjoy this experience immensely.

From there we were bused to the dining hall, where we had lunch with the delegates. We had an opportunity to talk with them and get a general sense of how they felt about the academy. They thought it was one of the greatest experiences of their lives. I spoke with a youth all the way from South Carolina who heard about the program, applied online and was accepted.

Then it was back to the flight line for a static display of military equipment and photographs. Among the more interesting pieces of equipment was a Soviet IL-39 jet trainer, with Czechoslovakian markings and an A-10 Thunderbolt II (Warthog). There were also Army snipers with their equipment, wearing their 'Ghillie' suits. The delegates were very excited by the displays.

Following the static display we held our quarterly Board of Directors meeting and then it was back to the CH-47 for the flight home. There were thunderstorms between Alpena and Lansing, so we detoured to the west and came in behind the weather.



must not allow their personal feelings to intrude; an antagonistic, critical, or even abusive attitude on the part of a claimant should not, in any instance, influence the officers in the handling of the case. Fairness and courtesy must at all times be shown to applicants by all employees whose duties bring them in contact, directly or indirectly, with the Department's claimants.

Evidently this rating specialist fell asleep in the training class when this topic was covered.

Through the efforts of the Advocate and the veteran, they were able to secure actual treatment records from the 1960s forward that showed that the veteran did have the condition when he said he did. A VA rating of April 2002 granted service-connection under the presumptive provision with a 10% evaluation.

Everything was fine with the veteran until 2008 when his condition increased in severity and he contacted this service. The VA rating of August of 2009 then granted him an increase to a 60% evaluation. He was then counseled by our staff member that he met the basic criteria of Individual Unemployability (IU) and should apply. The Advocate walked the veteran through every step to insure that the claim was well developed. On May 28, 2010 the veteran was granted IU.

The veteran and the Advocate could have given up after the denial in 2001. The Advocate could have said we gave it our best shot. Today, as a result of the action and guidance by our staff, the veteran can relax a little more comfortably. He also has the assurance that if something should happen to him, his wife has been instructed to contact us and will be well represented.

Greetings Comrades,

We are now one month into the 2010-2011 VFW Year. In the past month I have visited 13 out of 27 Posts within the 6th District and we have had our planning meeting. I would like to recap our planning meeting. First, the Commander set the dates for his Post visits. Second, we set the dates for 6th District meetings for the year and they are as follows: Sunday, 19 September at 9 a.m., VFW Post 4357-Brighton. The Brighton Post will conduct a POW/MIA ceremony. The second 6th District meeting will be on Saturday, 4 December at 11 a.m., VFW Post 7309-Mason. The Mason Post will conduct the Pearl Harbor Memorial Service. The third is Saturday, the 19th of March, 2011 at 11 a.m., VFW Post 701. This will be the Voice of Democracy and Patriots Pen Award ceremony for the 6th District. The 4th is Saturday, the 7th of May, at 11 a.m., VFW Post 9656-Lambertville. The Lambertville Post will conduct a Memorial Day Service. The 6th District Testimonial is under review, due to a conflict with the Department of Michigan 2011-2012 VFW Planning Conference.

As your District Commander, I have set goals for the 6th District. My first goal is that every Post in the District achieves 125 All-State Points. There is in excess of 300 points in the All-State Program and you can obtain the 125 without spending any funds. Funding is an issue with several of the Posts, and I understand this, but 125 points is obtainable without spending a dime. Do not look at the All-State Program as a competition, but as a measure to see if your Post is meeting the standards of a viable VFW Post.

The second goal is a 2% increase in membership. I have provided a spreadsheet that contains three different goals. The Department goal is 100%, which includes 2% new and reinstated members. The District goal is 102%. If we are not growing, we are withering away. Reductions in numbers are not acceptable. The National goal, All-American, is stiff; it varies based on the division code assigned. This goal previously provided is being revised due to a change from VFW National Headquarters. You will receive the new goals at the first District meeting. Depending on the size of the Post, you will need to increase your membership anywhere from 18 to 60 members.

The third goal is proper reporting of activity and hospital reports. These reports reflect the basis of the All-State Program. If you do not report, Department Headquarters does not know what you are doing to meet our objectives: "The purposes of the corporation are fraternal, patriotic, historical, charitable, and education and are: to preserve and strengthen comradeship among its members; to assist worthy comrades; to perpetuate the memory and history of our dead, and to assist their widows and orphans; to maintain true allegiance to the Government of the United States, and fidelity to its Constitution and laws; to foster true patriotism; to maintain and extend the institution of American freedom; and to preserve and defend the United States from all enemies." This is what we are about. We need to accomplish the whole package, not just the ones we want to follow. Activity, hospital and

The lifeblood of our organization is MEMBERSHIP.



## VFW Post 9656 Represents Michigan at Arlington Cemetery

Every year on Memorial Day there is a solemn and reverent ceremony at the Tomb of the Unknowns in Arlington Cemetery to honor our war dead. Arlington Cemetery was originally the grounds for Arlington House, to be built as a tribute to George Washington by his adopted son. There are currently over 250,000 graves and of these, 5,000 are the remains of unknown soldiers. The first interment occurred on May 13, 1864. The sarcophagus for the Tomb of the Unknowns is made of marble and there are three Greek figures sculpted into the marble that face Washington, D.C. These

figures represent Peace, Victory and Valor. On the east side of the tomb, carved into the marble panel are the words "Here Rests in Honored Glory an American Soldier Known but to God."

The American soldier from World War I resting in the tomb received both the Victoria Cross and the Medal of Honor and the World War II veterans all received the Medal of Honor.

Therefore, it was with much pride that the VFW Post 9656 was able to represent the state of Michigan with our wreaths. The Ladies Auxiliary to the Post has been

laying a wreath for the past three years, and the Post itself has been doing so for the past two years. In addition to the wreath-laying ceremony, members of the Post also passed out 1,000 flags to visitors at the cemetery. Members of Post 9656 were also asked to lay the wreath for the District of Columbia, as their members were laying the wreath for the National VFW. This request came from the National Commander of the VFW, Thomas Tradewell. Post Commander Richard Schroeder and several Post members represented Post 9656 at this awe-inspiring event.

## Meaning of Memorial Day

*A message from VFW National Commander Tradewell...*



It's a sacred day to all war veterans. None need to be reminded of the reason that Memorial Day must be commemorated. But what about the general public, and more important, future generations? Do most non-veterans really recognize the importance of the day honoring their fellow Americans killed in war?

Judging from what Memorial Day has become – simply another day off from work – the answer is a resounding no. Perhaps a reminder is due then, and it is the duty of each and every veteran to relay the message.

Sacrifice is meaningless without remembrance. America's collective consciousness demands that all citizens recall and be aware of the deaths of their fellow countrymen during wartime.

Far too often, the nation as a whole

takes for granted the freedoms all Americans enjoy. Those freedoms were paid for with the lives of others few of us actually knew. That's why they are all collectively remembered on one special day.

This should be regarded as a civic obligation. For this is a national debt that can only be truly repaid by individual Americans. By honoring the nation's war dead, we preserve their memory and thus, their service and sacrifice in the memories of future generations.

They came from all walks of life and regions of the country. But they all had one thing in common – love of, and loyalty to, country. This bond cemented ties between them in times of trial, allowing a diverse lot of Americans to achieve monumental ends.

We remember the loss of loved ones, a sense of loss that takes group form. In essence, America is commemorating those who made the greatest sacrifice possible – giving one's own life on behalf of others.

Means of paying tribute vary. Pausing for a few moments of personal silence is available to everyone.

Attending commemorative ceremonies is the most visible way of demonstrating remembrance: Placing flags at gravesites, marching in parades, sponsoring patriotic programs, dedicating memorials and wearing Buddy Poppies are also examples.

Whether done individually or collectively, it is the thought that counts. Personal, as well as public, acts of remembering are the ideal. Public displays of patriotism are essential if the notion of remembering war dead is to be instilled in youth.

As America's older war veterans fast disappear from society's landscape, there are fewer and fewer standard-bearers left to carry the torch of remembrance. Such traditions will live on only if there is a vibrant movement to which that torch can be passed.

Now, more than in past years, the enduring relevance of Memorial Day should be clearly evident. With two wars underway, the public has no excuse not to remember.

This much is owed to the more than 5,400 Americans who have died thus far in Afghanistan and Iraq.

donation reporting is how we report our progress towards our objectives.

In the past month, I have visited 13 Posts. We have a lot of new officers in our Posts. In some cases, we have a clean sweep of officers and we need to get them trained. If you missed the training at Camp Trotter and Lansing at the Summer Conference, the last chance you have is October 8th and 9th at Sault Ste Marie, Kewadin Casino. Please do not miss the training. I have talked training at the planning meeting, and to the 13 Posts I have already visited. I go every year and I learn something new every year. This also gives you points towards your goal of 125. Up to 17 points is up for grabs on July 30th and 15 points at Sault Ste Marie. This is not cumulative.

A lot of Posts do not have the current podium edition of the National Bylaws. You need to replace them as soon as possible. I would not order until after 1 October 2010, when the new edition will be available.

Whether or not we agree with federal, state and local laws, we must follow them. No smoking in our Posts is the current law causing strife. You cannot pick and choose what laws you follow. Follow them! We are nonprofit organizations, but we are not exempt from sales tax; if you owe any, get them paid.

Activity and hospital reports are due no later than the 10th of each month. Do not be late. I receive a lot of complaints that the Posts are not getting full credit for what they believe they deserve. For the Post that has sent me their confirmation copy, I have forwarded the report to the appropriate chairperson. You will get credit. All other missing reports I have not received, so I cannot help those Posts. In addition, manual reports have to be

received by Department Headquarters no later than the 10th. After that date, you are late and will probably get credit, but will lose one All-State point. You must take into account mailing time. Amanda date stamps all reports when she gets them. Failure on the Post to submit the report on time, not taking into account mailing time, is not the Department's or District's fault. Our first district meeting will be a School of Instruction. We will be taking two hours to cover these reports, so bring your reports with you so we can go over them and find out why you might not have been getting credit. We can only fix what we see. I will have Comrade Hawkins, the Department Membership Director, as a guest. Membership is the topic of the day.

Now, with all the seriousness completed, what is the state of our District? From my point of view, we are not in bad shape. After two months, we have 20 out of 27 Posts reported in hospital and activity reporting. All-State points range from 10 to 62 points, with the average being 23.6% for the 20 reported Posts. Donations for the District are \$1,242.00, mostly in MAP and PAC pins. Community Service projects 677, Community Service hours 8,786, Community Service value \$63,181.72, Americanism projects 454, Youth Activity projects 90, Youth Activity hours 702, Youth Activity value \$16,260.58, Drug projects 18, Safety projects 18, Legislative projects 11 and PAC projects value \$50.00. Hospital reporting: workers 215, hours 1,372, donations \$3,082.06, equipment \$4,319.00, patients 887, miles 3,576, pints of blood 5, and Cancer donations \$51.00.

As you can see, we are not doing badly after two months of activity and this usually increases after the summer months. Keep up the outstanding work.



## VFW National Commander Slams Massachusetts School Committee No Pledge Decision

KANSAS CITY, Mo., June 30, 2010 – The National Commander of the Veterans of Foreign Wars of the U.S. is appalled over an Arlington, Mass., school committee decision to reject a 17-year-old student's request to allow others to voluntarily recite the Pledge of Allegiance because some educators are concerned "that it would be hard to find teachers willing to recite it."

Thomas J. Tradewell, Sr., a combat-wounded Vietnam veteran from Sussex, Wis., said the decision is particularly egregious while America is at war and preparing to celebrate Independence Day.

"I find it unconscionable that on the eve of our most patriotic holiday we are confronted with another reminder that the wars in Iraq and Afghanistan have largely receded from the collective public mind," he said. "Even worse is knowing that this school decision occurred just down the road from Lexington and Concord, where the opening battles of our Revolutionary War were fought. This is just another galling example of the total lack of respect some have for America's freedoms and values."

The decision by Arlington school officials to disallow recital of the pledge was made even though it would be strictly voluntary for teachers and students alike and in spite of receiving a petition signed by 700 people, along with letters of support from lawmakers including Sens. John Kerry (D-Mass.) and Joe Lieberman (I-Conn.)

"Flying the flag, reciting the Pledge of Allegiance and singing our National Anthem are traditions worth maintaining and certainly worth passing on to our nation's youth – it's imperative that we do," said Tradewell. "The 1.5 million members of the VFW find this school decision extremely disrespectful to the members of our armed forces, to those who served in uniform before them, and to history, and we hope that the parents and the community rise up and force a change before the school decides that calling someone an American is now politically incorrect."



## VFW Wants Full Life Insurance Disclosure

WASHINGTON, D.C., Aug. 4, 2010 – “News reports about life insurance companies profiting off our war dead struck an emotional nerve at every level,” said Thomas J. Tradewell, Sr., National Commander of the 2.1 million-member Veterans of Foreign Wars of the U.S. and its Auxiliaries.

“It may be a legal industry practice, but learning that a company is earning more interest than what they pay out to surviving families just reeks of corporate greed and irresponsibility.”

According to *Bloomberg News*, if beneficiaries do not request a lump sum payment or direct the money elsewhere, insurers are holding the funds in corporate accounts that provide ridiculously low interest rates, plus they are giving misleading guarantees about the safety of the funds.

For example, Bloomberg reported that Prudential in 2008 paid survivors 1 percent interest on their accounts, while the company itself earned a 4.8-percent return on the same account. Prudential is the nation’s second-largest life insurer and manages the Servicemember and Veterans Group Life Insurance programs for 6 million military and military retirees. MetLife, the country’s largest life insurer, provides insurance for all nonmilitary federal employees.

Prudential defended their practice by saying its Alliance Account “does not in any way take money from beneficiaries,” and that beneficiaries can withdraw the entire amount, plus interest, at anytime without penalty. Prudential admits the account is not FDIC insured – a fact disclosed in their material – but alluding to State Guaranty Funds protections is mis-

leading. State Guaranty Funds are non-government safety nets, similar to insurance to protect the policyholders of insurance companies that might fail. Only a fraction of the State Guaranty Funds provided in all 50 states and the District of Columbia would cover the top SGLI or VGLI amount of \$400,000.

“This entire issue is about full disclosure,” said Tradewell, a combat-wounded Vietnam veteran from Sussex, Wisconsin.

“I know that the interest rate my savings account is earning is far less than what my bank earns by virtue of them holding my money. The difference is I know that, the surviving families do not. They think their money is safe and earning a good rate of return, where in fact their money isn’t fully protected and only the insurance company is earning the profit, which just isn’t right.”

In the aftermath of the Bloomberg article, the Department of Veterans Affairs, who oversees the SGLI and VGLI insurance programs, announced last week it would investigate the holding practice. Rep. Deborah Halvorson (D-Ill.), the stepmother of an Army Special Forces soldier who was wounded in Afghanistan, introduced legislation to require companies to tell beneficiaries how their money will be invested, and how much the insurer stands to make from holding the funds. And New York Attorney General Andrew Cuomo announced an investigation of the practice, which Bloomberg reported has allowed more than 100 insurance carriers to retain and earn investment income on \$28 billion owed to life insurance beneficiaries around the country. MetLife is based in New York.

## VFW Announces New Web Site Coming Soon

## VFW Statement on Arlington National Cemetery

WASHINGTON, June 10, 2010 – “The Veterans of Foreign Wars of the U.S. is both angered and saddened over the Army Inspector General’s report that verified allegations of mismanagement and misplaced bodies at Arlington National Cemetery. We are angry that senior cemetery and possible Army officials permitted a climate of complacency not only to exist, but to exacerbate. We are angry about how long this condition would have continued unchallenged – lit-

erally in the backyard of Headquarters, U.S. Army – had it not been for one reporter who was doing his job. And the VFW is deeply saddened by the thought of all the family members who are just now learning that their loved one may, potentially, not be resting in peace. There is no excuse or apology great enough to erase their disappointment or anxiety.”

## Were You Stop-Lossed?

There are millions of dollars waiting to be claimed by service members and veterans who were stop-lossed, and time is running out!

Those eligible must submit their claim by October 21, 2010.

The DoD Web site links to service-specific sites, where you can get more information, or begin the RSLSP claim process.

The 2009 War Supplemental Appropriations Act established Retroactive Stop Loss Special Pay (RSLSP), providing \$500 for each month/partial month served in stop loss status. Service members, veterans, and beneficiaries of service members whose service was involuntarily extended under Stop Loss between Sept. 11, 2001 and Sept. 30, 2009 are eligible for RSLSP.

To receive this benefit, those who served under stop loss must submit a claim for the special pay. Throughout the year, the services have been reaching out to service members, veterans and their families through direct

mail, veteran service organizations and the media.

But there is still money left to be claimed, and the deadline is approaching. We’re reminding all service members who are eligible to submit a claim for the benefit available to them. The average benefit is \$3,700.

### Tell a Friend

We are also asking all current service members to ‘tell a friend’ – if you know someone who separated/retired and may be eligible for this benefit, remind them to submit a claim before the deadline!

**Note on Eligibility:** *Effective Dec. 19, 2009, per the Defense Appropriations Act, stop-lossed service members who voluntarily reenlisted or extended their service, and received a bonus for such reenlistment or extension of service, became no longer eligible to receive retroactive stop loss special pay.*

## Six Decades Later Pearl Harbor Casualty F3C Gerald George Lehman is Finally Coming Home

Sixty-nine years after the Japanese attack at Pearl Harbor on December 7, 1941, F3c Gerald George Lehman, USN, *USS Oklahoma* of Hancock, Michigan will be coming home. Lehman's remains were recently identified by the Joint POW/MIA Accounting Command (JPAC) and he will be buried in the family lot at the Forest Hill Cemetery, 47240 Green Acres Road, Houghton, Michigan on June 12, 2010.

Lehman was one of 429 casualties of the *USS Oklahoma*. When the ship was righted in 1943, remains were taken off and buried in the Halawa and Nu'uauu Naval Cemeteries. In 1949 with the creation of the National Memorial Cemetery of the Pacific (Punchbowl), the graves were disinterred and the remains transferred to the Punchbowl. At the time, the American Graves Registration Service recommended that 27 of these remains be re-designated with individual identification. However, this was rejected because an anthropologist refused to sign the nec-

essary papers, so they were buried as unknowns. In 2002, Ray Emory, Historian for the Pearl Harbor Survivors Association made this discovery and was able to provide enough convincing evidence to JPAC that they disinterred grave P-1002 which contained five remains. After five years had passed with no identifications made by JPAC, Emory contacted Bob Valley of the *USS Oklahoma* Family, Inc. in February 2008 and asked if he could begin a search for the families of the 27 men whose names could now be attached to their unidentified remains.

Contacting families was a challenge since most of the family members listed on the men's military records died long ago. However, relatives of 26 of 27 men have been found. With the assistance of family members and their representatives in Congress a letter campaign followed. Finally in July of 2008, JPAC identified three of the remains and they were returned to their respective families. The

first was F2c Lawrence A. Boxrucker of Dorchester, Wisconsin In September 2008. Next was Ens. Eldon P. Wyman of Portland, Oregon in October and then Ens. Irvin A.R. Thompson buried in Dixon, California in November. No further identifications were made until December 2009 with MM1c Charles H. Swanson, who will be buried in Arlington National Cemetery in 2010. The fifth and final identification of the five remains in grave P-1002 was in January 2010 with Gerald G. Lehman.

Twenty-two of the twenty-seven unknowns are still buried in three graves at the Punchbowl. The *USS Oklahoma* Family, Inc. and the families of these men continue to push for their identification. The agencies responsible for the decision are the Defense POW/Missing Personnel Office, the Department of the Navy and the Joint POW/MIA Accounting Command.





