## Department Service Officer SUCCESS STORY

From time to time we hold seminars pertaining to veteran's benefits, and in June of 2003 we met a former sailor who presented a unique problem.

The veteran indicated that he had previously been granted service connection for a debilitating right arm condition at a 50% evaluation from 1998. As a result, he was put on a Temporary Disability Retirement List (TDRL).

In conversing with the veteran who was wheelchair bound, we found out that he had suffered a stroke while (TDRL). He filed a claim for the residuals of AVM, but was denied in 1983 or '84 – he couldn't remember. It appears that the reason for the decision was that this condition was a congenital defect and that it had pre-existed active service.

Our staff member advised the veteran that we would like to take a look at his case. We told him that the VFW would represent him and that we would review his VA Claims folder.

After a review of the file, we submitted a claim for direct service-connection, only to have it denied once again in

September of 2005. We appealed that decision and requested a personal hearing, which was conducted in June of 2008. During the testimony, it was found that the veteran suffered a left eye injury on active duty and was subsequently treated for it.

The Board of Veterans Appeals' offered its finding on January 9, 2009, stating that an arteriovenous malformation (AVM) or related disorder was not recorded in the veteran's February 1980 service entrance examination report. Therefore, the veteran was presumed to have been in sound condition with respect to this disability at service entrance.

The BVA nevertheless found that the evidence of record clearly and unmistakably demonstrates the veteran's AVM is a congenital defect and as such, by its nature, pre-existed active service. In this regard, at the request of the BVA, the veteran's claims file was reviewed by an independent medical expert (IME) specializing in neurology. In a detailed and extensive report received by the BVA in September 2008, the IME opined, "(a)

## STATE SERVICE OFFICER

### Advocating for Others

In April of 2010 the way we do business changed dramatically when a Coalition of five Veterans Service Organization aligned to petition the State of Michigan for grants that helped found our delivery of service. The Veterans of Foreign Wars, The American Legion, Disabled America Veterans, Marine Corps League and Military Order of The Purple Heart, entered into an agreement that we would provide the best service possible with the resources allocated by the issuance of three grants.

The VFW took the Coalition lead after the grants were issued, and it has been a very interesting time for all of us. In taking the lead, we have cooperated with all parties to better equip our staff and assist our returning veteran population. We have come a long way from where we were to where we are today. Rome was not built in a day, and this network that we are trying to create will not be either.

As a Coalition, we have had attending training classes together, have shared information together, and worked together in order to make sure that we are good stewards of the appropriations that have been awarded through the grant process.

At this very moment we are in the process of petitioning the State of Michigan for new grants that will begin on October 1, 2011. It appears that there will be four grants, and once again, the Coalition will apply for the four available grants. It is the Coalition's firm belief that the Coalition can adequately provide

a higher level of expertise and professionalism than anyone in our line of advocacy.

We continue to face the backlog of claims; the timeliness of decisions rendered by the VA and, of course, the long appellate process. In 2006, the backlog in the appeals section was 1,272 cases. Today, it is rapidly approaching 6,000! In an effort to try and reduce that number, the Coalition is trying to avoid the appellate process by addressing the actual issue of why a claim may have been denied.

For instance, it could have been denied because some evidence or a report may not be part of the record, or maybe the veteran failed to report for an evaluation, or perhaps a medical opinion would help. So, instead of submitting a Notice of Disagreement, if we secured the evidence, or find that the veteran was willing to report for an evaluation, we would be ahead of the game. So we are aggressively looking for the obvious, that a simple fix may get the issue resolved. We want to do this within six months of the decision or earlier, so that we do not miss the appeal period of one year from the notice of denial.

Don't get me wrong – there are times that an appeal is necessary and we will do it when it is, in fact, necessary.

## New Assistant State Field Service Officer

cerebral AVM should be regarded as a congenital defect of the intracranial vasculature and is not an acquired disorder. The cerebral AVM is considered to develop in the human brain during fetal or early post-natal life...it can and should be assumed that the AVM in the veteran's brain pre-existed military service." Furthermore, in a December 2008 statement, a VA neurologist, indicated to be the Chief of Neurology Section at a VA Medical Center, concurred in the IME's opinion. For these reasons, the BVA found that the veteran's AVM clearly and unmistakably pre-existed his active service.

As to the question of aggravation, the BVA noted that the September 2008 IME opinion includes a finding that there exists clear and unmistakable evidence that the veteran's AVM was not aggravated beyond its normal progression during active military service. However, the BVA observes the IME uncharacteristically did not provide a rationale or basis for this aspect of his opinion, but rather provided only a one-word answer to the question posed. By contrast, the VA neurologist noted that, while he knows of no evidence supporting either conclusion, "it is certainly conceivable that the AVM could have been influenced by the blow to the left eye (in a July 1980 injury)." In weighing these differing opinions, the BVA noted that both physicians were highly qualified and highly credentialed in their fields, but that only the VA neurologist provided an underlying rationale for his opinion on this critical point. As such, the BVA found that there is not clear and unmistakable evidence to establish that the veteran's AVM was not aggravated beyond its normal progression during active service. Therefore, the presumption of sound condition upon entry into service is not rebutted, and the veteran is presumed to have been in sound condition upon entering service.

If the government fails to rebut the presumption of soundness under 38 USCA §1111, the veteran's claim is one for service connection. This means that no deduction for the degree of disability existing at the time of entrance will be made if a rating is awarded.

Service medical records indicate the veteran sought treatment approximately seven months after entrance into active service for headaches, tenderness to the temple and chronic reflex sympathetic dystrophy of the right upper extremity. In this regard, an October 1980 service treatment record indicates the veteran complained of headaches from a left eye injury in approximately June 1980, with no visible trauma. Furthermore, a January 1981 neurological examination showed evidence of extreme weakness and mild atrophy of all right hand muscles,

including thenar and hypothenar emi-nence. At a February 1981 neurological examination, the veteran was diagnosed as having reflex sympathetic dystrophy.

The IME opined that there is a greater than 50% probability that all in-service symptomatology reported by the veteran was causally related to his cerebral AVM. Again, the VA neurologist concurred in his December 2008 opinion. Yet, upon clinical evaluation at entrance into service, no disability or symptomatology now known to have been attributable to his AVM was noted. The competent medical evidence demonstrates that the veteran was essentially in good health upon entry into service, and underwent a dramatic increase in symptomatology and superimposed AVM-related disease processes several months after entrance into active service. As such, the BVA found, consistent with the December 2008 VA neurologist's opinion, while the veteran's cerebral AVM is a congenital defect, it cannot be ruled out that the AVM underwent an increase in severity due to superimposed disease and/or injury during service, resulting in chronic disability, to include a post-service stroke and craniotomy.

The record clearly indicates that the veteran's AVM clearly and unmistakably preexisted service, but does not clearly and unmistakably indicate the veteran's condition was not aggravated beyond its normal progression during active service, so the presumption of soundness applies. The medical experts who have addressed this matter have found that the veteran did experience worsening manifestations of his AVM during service, and that the veteran's in-service chronic reflex sympathetic dystrophy of the right upper extremity, and stroke and resulting hemiplegia shortly after service, were manifestations of his AVM and related disease processes. In light of the December 2008 opinion of the Chief of Neurology at a VA Medical Center, the government did not meet its evidentiary burden of showing that the AVM clearly and unmistakably did not worsen beyond natural progress during active service, and it is clear that a dramatic worsening of symptoms did take place several months into active service. The BVA concluded that all benefit of the doubt be ruled in favor of the veteran, and the BVA found that service connection for residuals of a stroke, status post craniotomy with removal of left cerebral AVM, was granted.

What started out as a seminar in 2003, finished six years later in 2009 with a retroactive award of \$109,000 to the veteran! The overall success of this story is that the Advocate listened to what the veteran had to say, and then got it on record with a personal hearing.





**“Suicide Awareness Month”**

The National Ladies Auxiliary to the Veterans of Foreign Wars has declared September as “Suicide Awareness Month.” We, as patriots, need to follow through with dedication to instill into the public that this is a very serious situation. Suicide, in any case, is serious and very hard on the family; but we need to educate everyone that active duty soldiers and veterans are committing suicide and the numbers are on the rise. The percentages are climbing, not just for the male soldier but also for the female soldier. The male soldier suicide rate has more than doubled since 2004 from 10 per 100,000 to 22 per 100,000. Last year, when National Guard and reservists’ data were included, an average of 25 soldiers killed themselves each month.

Ladies, this is a travesty!

*Teardrops* is something that National is asking us to wear every day throughout September. The *Teardrops* can also be found on the National Web site at: [www.ladiesauxvfw.org](http://www.ladiesauxvfw.org)

This is a very simple gesture for us to do. Cut the Teardrops out, wear this symbol everyday and when asked what they stand for – have your information ready and talk about it!

- Talking about feeling hopeless or having no reason to live.

- Talking about feeling trapped or in unbearable pain.
- Displaying extreme mood swings.
- Talking about being a burden to others.

These signs may mean someone is at risk for suicide. Risk is greater if a behavior is new or has increased and if it seems related to a painful event, loss or change.



## Agent Orange Presumptions in Jeopardy

**VFW opposes amendment that would change how presumptive disabilities would be determined.**

The Veterans of Foreign Wars of the U.S. is adamantly opposed to an amendment proposed by Sen. Tom Coburn (R-OK) to change the manner in which presumptive disabilities related to exposure to Agent Orange would be determined. The senator wants to require veterans to prove a positive connection between Agent Orange exposure and one or more of the 15 presumptive illnesses that the VA now recognizes. We cannot allow this amendment to pass.

Vietnam veterans have suffered long enough from the effects of exposure to Agent Orange. For decades we told the

government that being exposed to Agent Orange made veterans sick. Now that the VA Secretary has determined he had the scientific evidence required to recognize the disabilities, we cannot allow a change in presumptive rules just because the government can't balance its own budget.

The cost of caring for our nation's veterans continues long after the last shots are fired. America and the United States Congress must live up to that obligation. Call or e-mail both your U.S. Senators today and tell them that **"Coburn Amendment #564 to H.R. 2055 is a deal breaker with America's veterans!"**

## Veteran Volunteer at VA Ann Arbor Healthcare System Honored with National Recognition



*Twenty-year volunteer at the Ann Arbor VA, Past Commander Post 423 John Kinzinger was recognized as the 2011 VA National Male Volunteer of the Year. Post 423 supports many of the projects that Kinzinger leads, such as a special Christmas Program, clothing drive for the Ann Arbor VA Medical Center, an annual 'Car Show For Vets' which has donated about \$40,000 for special projects at the Ann Arbor VA, monthly VA Bingos, and other worthy special projects for hospitalized Veterans.*

Ann Arbor, MI – John Kinzinger, an active volunteer at the VA Ann Arbor Healthcare System (VAAHS) and in the Ann Arbor community, was recognized nationally as the 2010 VA Voluntary Service Male Volunteer of the Year.

Kinzinger has served as a dedicated volunteer at VAAHS for almost two decades, donating over one thousand hours to Veteran patients while organizing events, such as the annual Halloween and Christmas bedside visits, the annual "Car Show for Vets" which is combined with the Welcome Home Celebration for returning Iraq/Afghanistan Veterans, and serving as Ann Arbor's VAVS Representative for the Vietnam Veterans of America.

In addition to his service to the Veterans at VAAHS, Kinzinger leads a group who regularly send care packages to U.S. military service members serving in Iraq and Afghanistan. Over the past six years, they have sent over 1,500 boxes. He also helped to fund and build Washtenaw County's Vietnam Veteran Memorial in Ypsilanti Township. Kinzinger and his wife, Jane, are editors of the award-winning newsletter for the local chapter of the Vietnam Veterans of America (VVA). He also serves in leadership roles for Operation Never Forgotten, Operation SAS (Sports, Afield and Stream), the VVA Chapter 310, the VFW Post 423, the Veterans Honor Guard of Washtenaw County, and as the leader of a group of Vietnam Veterans who do classroom talks on their experiences in Vietnam and after they came home.

Kinzinger received his award at the 65th Annual VA Voluntary Service (VAVS) National Advisory Committee meeting in Cincinnati, Ohio on April 27, 2011.

## Deficit Talks and Veterans

**A letter to VFW members, VFW Ladies Auxiliary and Supporters**

July 26, 2011

Dear VFW, Ladies Auxiliary and Supporters:

The Veterans of Foreign Wars of the United States is attending a White House meeting this afternoon to hear an Administration update on debt negotiations as they relate to veterans and military families. This letter is to share with you what the VFW knows to date.

First and foremost, the VFW has not and will not acquiesce to any Administration or Congressional proposal to deny or limit healthcare programs or benefits to veterans, or to increase fees on any eligible veteran, service member, family member or survivor.

We know of active legislation to increase TRICARE fees for working age retirees, and there are discussions to change the annual cost of living adjustment calculations for military retirees and veterans receiving compensation for their disabilities. We know of recommendations to reduce annual military raises, as well as to totally change the current military retirement system to make it resemble civilian businesses. And we know of discussions to end category 7 and 8 enrollments at the Department of Veterans Affairs, or to charge them a \$250 annual enrollment fee with increased prescription costs.

With your assistance last week, we were able to defeat a proposal to eliminate presumptive service-connections for VA compensation. The VFW will continue to actively monitor and work to defeat the above proposals and any other recommendations. We will also engage VFW members and supporters to rally their members in Congress to defeat them, too.

The main problem with the ongoing budget negotiations is that the meetings have been held in such secrecy that many members of Congress and advocates like the VFW have not been allowed into the room to explain the impact of such toxic proposals on veterans, military personnel and their families.

The VFW recognizes the enormity of the task before the White House and Congress to cut federal spending and to reduce the national debt, but we also know that when the nation talks about sacrifice, we know who answers that call. Your VFW has been working hard for 112 years to ensure our nation fulfills a promise it made to care for veterans, our military, their families and survivors. We are not about to stop now.

As Americans, it is our patriotic duty to acknowledge the men and women that gave so much, present memorials for the 9-11 victims, and to educate everyone on the crisis of military personnel suicides. **VFW Joins in Houston National Cemetery Censorship Lawsuit***"This is a point in case of bureaucracy..."*

KANSAS CITY, MO, July 1, 2011 -- The national commander of America's largest and oldest major combat veterans' organization is appalled over allegations of religious censorship at one of the nation's national cemeteries, calling it a case of "bureaucracy running amok."

"This is a point in case of bureaucracy...or rather, a classic example of a bureaucrat running amok. In spite of VA policy, the cemetery director is making up her own rules and has imposed hurtful, unilateral restrictions of her own choosing," said Richard L. Eubank, the national commander of the 2.1 million-member Veterans of Foreign Wars of the U.S. and its Auxiliaries.

Texas-based Liberty Institute has filed suit on behalf of the VFW, American Legion, and The National Memorial Ladies over allegations of religious hostility and unlawful censorship by the VA and its director of the Houston National Cemetery. "They've told the VFW and the American Legion that

they cannot have prayer during the burial services of our veterans, unless the family requests it in writing and submits the prayer for pre-approval," said Liberty Institute general counsel Jeff Mateer.

The VA, meanwhile, insists its national cemeteries welcome appropriate religious recitations. The "VA values and respects every veteran and their family's right to a burial service that honors their faith tradition," said Keith Ethridge, director of VA's National Chaplain Center. The Houston cemetery superintendent has declined to speak to the media despite numerous requests.

"Generations of patriotic Americans have fought, bled and died to help defend the U.S. Constitution –that great document provides and guarantees fundamental rights of religious expression and freedom of speech. Those basic tenets are clearly being violated at the cemetery and that simply cannot be tolerated," concluded Eubank.

This past May 28th, 2011 the Fruitport Polar Bear VFW Post 3734, held a dedication of a plaque commemorating Muskegon County, Michigan's two Medal of Honor recipients in the Fruitport Veterans Park, located in the Village of Fruitport.

The bronze plaque at the base of the stone is 97% bronze and was made in the United States of America. The cost of the bronze plaque was \$1,000, with all the money being raised locally, including donations from VFW Post 3734.

The plaque reads:

"A U.S. Army Civil War Medal of Honor; and a Korean War U.S. Navy Medal of Honor; and "Muskegon County Medal of Honor Recipients."

Followed by:

"Sergeant Alexander U. McHale: United States Army, Company C, 26th Michigan Infantry. Civil War. Entered service at Muskegon, Michigan. MOH award for conspicuous gallantry on May 12th, 1864 at Spotsylvania Court House, Virginia. Captured a Confederate flag in a charge, threw the flag over in front of the works and continued in the charge on the enemy. Corporal Duane Edgar Dewey: United States Marine

Corps Reserve, Company E, 2nd Battalion, 5th Marine Division (Reinforced). Korean War. Entered service at Muskegon, Michigan. MOH award for conspicuous gallantry above and beyond the call of duty near Panmunjon, Korea, April 16th, 1952. Corporal Dewey, while wounded, smothered an incoming Communist grenade with his body, personally absorbing the full force of the explosion, thus saving the lives of his fellow Marines."

The Fruitport Township, Michigan Veterans Park has plaques and monuments commemorating those who died in World War I, World War II, the Korean War, the Vietnam War and the Iraq War.

## VFW Post 423

### Sends Care Packages to the Troops



VFW Post 423 continues to Support Our Troops by sending care packages. Every other month before their regular membership meeting, Post and Auxiliary members pack 20-30 large care packages and mail them to troops serving in Iraq and Afghanistan. To date, VFW Post 423 has mailed almost 1,000 care packages.

This program has become somewhat of a local community effort, too. Members of the local Pittsfield Senior Center help by knitting hundreds of wool scarves each year, which are mailed to the troops in Afghanistan for their colder months. That personal touch is very

warming for the troops. Local church groups and individuals donate items and cash for postage.

Most importantly, Post 423 packs special 'women only' packages for female troopers. They may not be in front-line fighting units, but the number of women serving in the war zones is much greater than in earlier wars. The numbers of them who have made the supreme sacrifice (over 140 died in theater, so far) far outnumber that of prior wars. IEDs, mortar attacks and convoy ambushes seem to be responsible for these differences.

## 10 FOR 10: VFW Won't Stand for Broken Promises

**Update: VFW mobilizes to protect military benefits as Congress looks to slash spending**

August 09, 2011 – Recently, when Congress voted to raise the nation's debt ceiling, they specifically targeted national security spending to absorb many of the cuts, indicating that Department of Defense personnel programs and VA benefits would not be spared.

Leaders in Congress have already discussed cutting or eliminating 10 benefits affecting military members, veterans and their families in recent months, and the VFW believes that these toxic proposals will once again gain momentum as Con-

gress looks for ways to tighten its belt. An in-depth explanation of each proposed cut is included below.

America's all-volunteer military has shouldered a multi-theater war all by themselves for almost 10 years. They did so without question, and often with tremendous sacrifice to themselves and their families.

Americans understand the scope of the national debt crisis; a crisis that could have serious repercussions on a military at war and a veterans' population that has

already sacrificed much for the nation. However, instead of debating and enacting meaningful fiscal reforms, some in Congress have proposed plans that would leave America's military and her veterans to shoulder more of the national debt.

This "10 for 10" plan – to cut 10 specific benefits to pay for 10 years of war – is a breach of faith with America's military and veteran families, and the national commander of the Veterans of Foreign Wars of the U.S. and its Auxiliaries is calling upon his 2 million mem-

bers to fight it.

"Our military and veterans have earned each of the 10 benefits Congress is proposing to cut," said VFW National Commander Richard L. Eubank, a retired Marine and Vietnam combat veteran from Eugene, Oregon.

"Our nation broke a similar promise to her World War I veterans," he said. "It took the VFW to lead thousands of them in a march on Washington until Congress

made the responsible choice to support them. The VFW wouldn't stand for broken promises then and we won't stand for it now."

The 10 ways Congress is targeting military and veterans' benefits during today's difficult fiscal times are to:

- Increase healthcare premiums for military retirees on TRICARE
- Increase pharmaceutical fees for troops, families and retirees
- Eliminate presumptive service-connected conditions for disabled and ill veterans
- Lock out or increase fees for Department of Veterans Affairs Priority Groups 7 and 8 veterans
- Reduce cost-of-living allowances
- Freeze military pay
- End government subsidies to military commissaries
- Eliminate Department of Defense elementary schools stateside
- Eliminate the 20-year military retirement plan
- Eliminate DoD tuition reimbursement programs for service members

While Congress publicly debated raising the nation's debt ceiling, the VFW was concerned that many of the proposed cuts were being discussed behind closed doors. The VFW has the same concerns over the new bipartisan "Gang of 12" Super Congress tasked to develop the nation's debt reduction plan. Eubank said the VFW recognizes that the nation must make difficult fiscal decisions, but the programs and benefits pro-

vided to veterans and military families were prepaid in full through their honorable service and sacrifice.

"Unlike other government-funded entitlement programs, veterans earned their benefits by making a national commitment that 99 percent of other Americans are simply unwilling to make," said Eubank. "To ask these same men and women to sacrifice more is simply unconscionable."

The VFW also believes that cutting the 10 benefits could have tremendous impact on military recruiting and readiness, and threaten the future viability of the all-volunteer force. Healthcare, education, a retirement system and family programs are critical factors in retaining talented personnel in a low-paying and extremely dangerous profession.

Eubank said as the debate over fiscal responsibility continues to unfold in Washington, the VFW will work to ensure that military and veterans' benefits remain intact.

In the coming weeks, the VFW will continue to put pressure on Congress to ensure proposed fiscal reforms do not negatively affect troops, veterans or their families.

**VFW Testifies to Improve Veterans' Access to Care**

**Testimony before the House Veterans Affairs Subcommittee on Health on seven pending bills**

WASHINGTON, July 26, 2011 – The Veterans of Foreign Wars of the U.S. testified yesterday before the House Veterans Affairs Subcommittee on Health on seven pending bills that address issues such as removing hurdles to care for veterans, improving services for those suffering from the invisible wounds of war, and ensuring that VA land is used to serve the mission of VA.

VFW Senior Legislative Associate Shane Barker presented the organization's views on access to health care facilities for veterans with service dogs, broadening the scope of rehabilitative models for veterans suffering from traumatic brain injuries, strengthening zero-tolerance policies for sexual assault inside VA medical facilities, and ensuring that VA's enhanced use-lease agreements conform to VA's mission of providing services to veterans.

The VFW supports many of the ideas proposed by the subcommittee, such as improving Spina Bifida care for children of veterans exposed to Agent Orange and streamlining VA reimbursements to state

veterans' homes. The VFW, however, did oppose a bill to create a VA therapy dog training program for troops suffering from post-traumatic stress, calling instead for VA to partner with private organizations already experienced in training therapy dogs.

"We support the idea behind this legislation, but believe it would be better achieved through established private sector organizations with sufficient oversight by VA," said Barker. "Such changes would achieve greater results with no further cost to VA."

### VFW Commander-in-Chief 1999-2000 to be National Rep. for Fall Conference



John W. Smart of Nashua, New Hampshire, was elected VFW Commander-in-Chief at the organization's 100th National Convention in Kansas City, Missouri on August 20, 1999.
