## IMPORTANT MESSAGE FOR ALL MICHIGAN VETERANS

June 27, 2025

Comrades of Michigan:

I am writing to you to request your help.

I am sure that you have read the VFW warnings about "Claim Sharks" preying on veterans seeking entitled benefits from the Veterans Administration.

Comrades, the fight against these claim predators has come to Michigan. In May 2025 the State Senate passed SB215 which opens the door for these predators to operate in Michigan under the guise of freedom of choice. SB215 has now been referred to the State House Appropriations Committee for their consideration. We expect that SB215 will be scheduled for Committee Hearings soon.

This legislation is a repeat of the failed attempt in the last legislative session of SB 1103 which also passed in the State Senate but failed to survive in the House. You and I need to make sure that SB215 suffers the same failure in this legislature. The members of the State House Appropriations Committee and every member of the House must hear our voices loud and clear: DO NOT FEED THE SHARKS!

In May 2024 the Michigan VFW State Convention delegates adopted a very simple resolution: "Be it Resolved: That the Department of Michigan Veterans of Foreign Wars supports state legislation that prohibits anyone other than the claimant veteran themselves or a veteran representative accredited through the VA from filing or assisting in the filing of claims on behalf of any veteran or claimant living in the State of Michigan, and

**Be it Further Resolved:** That the Department of Michigan Veterans of Foreign Wars supports state legislation that would require state prosecution of anyone charging any fee for assisting any veteran or claimant residing in the State of Michigan in preparing, filing or the prosecution of any VA claim."

The position of the VFW has not changed! We have not wavered in our opposition to any attempt to circumvent through the passage of State Law the explicit intent of Title 38, US Code of Federal Regulations, Section 14.629(b)(1) which prohibits any party from assisting a veteran in the preparation, presentation, or prosecution of a Department Veterans Affairs (VA) claim unless they are accredited through VA for such purposes. SB215 would do just that, circumvent Federal Law under the guise of State Law. SB215 would put the State of Michigan in violation of existing Federal Law, and we cannot allow it.
